**Public Comments:**

Mack Currence inquired about the status of signage in the VOLP. Signage needs to be posted concerning skateboarding at the Gazebo and Clock Tower and to not feed the ducks in order to inform the public and to make formal the policies of the VOLP. According to the Sheriff, signage would go along way in helping to prevent problems. The question was also raised as to the fines for feeding the ducks. Mr. Currence wanted to know if we have a person or persons in place to handle the vandalism especially the graffiti within 24 – 48 hours, instead of relying entirely on volunteers.

**Ponds:**

The Pond Committee is not meeting until September, since Norris Jeffrey, the chairman has resigned.

**Park and Recreational Events:**

The Fourth of July was a tremendous success. Thanks to all the volunteers who helped make the day a success. With the sale of concessions, the day cost the taxpayers \$612.00. Improvements that need to be made for next year are:

The speakers need to also face the food areas.  
We need two food lines.  
More bottled water needs to be purchased.  
Larger cups need to be used.  
May want to consider buying more hotdogs since we ran out of food however it is better to run out than have leftovers.

The first Dive-in movie was a success with over a 100 people participating. The next scheduled Dive-in will be August 11, 2005.

**Pool Issues:**

There are 205 pool memberships \$39,369.00 with walk-up for the season as of July 25 - \$4,281.00. We have exceeded our goal of \$42,000.00.

**Landscaping:**

Lucas is working on treating the ponds and installing the new fountains at Russell Park. The area between the pool and the tennis courts has an odor. Pat Hunt will need to discuss with Lucas what needs to be done to solve the problem.

Martha Norcross sent a letter concerning area 13. Pat Hunt is handling her questions concerning the lack of landscaping care.

Area 12 has a quite a bit of litter and a dead tree that needs to be removed.

The decision to trim the trees along the sidewalks in the VOLP needs to be made to determine whether the homeowners or the village will pay to have the work completed. Lucas has supplied an estimate of \$700.00 to trim the trees. If Lucas does the work, the trees will all be the same.

Mike Tisdell has repaired the Gazebo Lights and will replace the fittings on the Kite Girl lights to prevent easy movement of the lights. He has also placed locks on the pump houses at the Clock Tower.

The Garden Club would like to decorate a tree for the Community Center. The tree would be installed before the tour of homes. This was approved.

The basketball rim that is bent needs to be removed before the backboard is damaged also.
